- 2. The analysis of the Feedback on Curricular Aspects has been uploaded in the College website in graphical representation.
- 3. The analysis of the Feedback on Curricular Aspects was placed in the meeting of the Governing Body of the College for further processing.
- 4. The analysis of the Feedback on Curricular Aspects was placed in the meeting of the IQAC which has comprehensively discussed the matter and it has suggested to take remedial actions on the shortcomings on curricular aspects. At the same time, IQAC advocated for augmentation of ICT infrastructure of the College.
