ADMISSION NOTICE/GUIDELINES

Admission to the Two-Year B.Ed. Programme (2026–2028)

In continuation of the earlier notice SU/ACR/Admission/FYUGP/2025/341 dated 06-05-2026, this is for the information of all candidates who have qualified in the B.Ed. Entrance Test (BEDET), 2026, that the admission to the Two-Year B.Ed. Programme (2026–2028) shall be conducted physically along with the verification of the original documents on the 23rd July 2026 (instead of earlier notified date – 20-07-2026).

- 1) Total Intake Capacity : 50 Seats
- 2) Weightage for Merit List:
 - B.Ed. Entrance Test (BEDET), 2026 : 60%
 - HSLC (Class X) Examination : 10%
 - Higher Secondary (10+2) Examination : 10%
 - Graduation/Post-Graduation - percentage of all Subjects (whichever is higher) : 20%
 - Total : 100%
- 3) Reservation of seats shall be made as per the prevailing norms of the Government of Assam vide Letter No. DHE/EG/Misc/79/2023/24 dated 20-07-2023 and Ecf No. 355788/2 dated 11-08-2023, as mentioned below:

- 4) **Tie-Breaking Criteria:** In the event of two or more candidates securing the same composite score, the order of merit shall be determined in the following order:
 - a) The first point of tie breaking - Higher academic qualification.



- b) If tied even after the first point of tie breaking - Higher marks in the Major/Honours courses in the Bachelor's degree examination.
- c) If tied even after the second point of tie breaking - Older candidate (earlier Date of Birth).

5) **Admission Procedure**

Candidates whose names appear in the merit list shall report to the Member Secretary of the Admission Committee, Dr. Parag Rajkhowa in the JPCM Hall of the University, on the 23rd July, 2026 before **11:00 a.m.**

During counselling, they shall produce:

- Printed copy of the finally submitted online application.
- Self-attested photocopies of all uploaded documents.
- **All original documents for verification.**

Failure to report within the stipulated time or failure to produce the required documents shall result in cancellation of the candidature, and the vacant seat shall be offered to the next eligible candidate as per the Merit List.

6) **Documents to be verified physically:**

Candidates shall produce the following documents in original during counselling:

- HSLC Marksheet
- Higher Secondary Marksheet
- Graduation Marksheet(s)#
- Post-Graduation Marksheet(s) (if claiming higher percentage or Tie-Breaking)
- Proof of Date of Birth
- Caste Certificate (if applicable)
- EWS Certificate (if applicable)
- PwD Certificate (if applicable)
- Gap Certificate (if applicable)
- Any other document as required by Sibsagar University.

7) **Admission Fee - Revised (1st Semester)**

- B.Ed. (Arts Method) : Rs. 33,500/-
- B.Ed. (Science Method) : Rs. 34,000/-

The Admission Fee - Revised shall be paid only after successful verification of original documents on the date of admission. The admission fee may be deposited through Cash, Online Payment, Bank Transfer (NEFT/RTGS/IMPS), or UPI (Google Pay/GPay). Candidates making payment through online modes shall produce the transaction receipt/UTR number as proof of payment to the department for final approval of admission. Bank account details for online transfer shall be notified separately/displayed at the time of admission.



8) **Important Instructions**

- Incomplete applications or applications without the required documents shall not be considered.
- Submission of false or incorrect information or forged documents shall lead to cancellation of candidature/admission at any stage.
- Mere inclusion in the merit list does not guarantee admission. Admission shall be subject to verification of original documents, fulfilment of eligibility criteria, availability of seats and approval of the competent authority.
- Sibsagar University reserves the right to cancel any admission if any discrepancy is detected at any stage.
- The decision of Sibsagar University regarding merit preparation, tie-breaking, document verification and admission shall be final and binding upon all.

- Date of Admission : 23rd July 2026
- Reporting Time : On or before 11:00 a.m.
